UPCOMING SAFEGUARDING TRAINING

However, from a safeguarding point of view we are not waiting for the lockdown to end before we start our new safeguarding training packages on the back of the updated Good Practice 5 Safeguarding document.

We have been working hard and have put together the new basic safeguarding package which is aimed at everyone who visits and uses our churches and church premises, in whatever capacity you may do so.

It is a package which lasts about 90 minutes and I will be initially providing this online using the Zoom multi-media package. To access the training, you will need an internet connection and a device such as a laptop or tablet with a camera. You will need to download the Zoom app, which is free and I will conduct the training in this manner.

An email will be sent out to all churches shortly in the coming weeks giving details on when the training is to be given and how you can access it. For those who are based in Northern Synod it will also be advertised in the Northern Synod newsletter as well as on the Synod's Website.

Could I ask to you all to try and give some of your valuable time to this training so we can ensure that we are at the best we can be should we need to deal with any sort of safeguarding concern.

I want to conclude by wishing my continued thoughts to you all and I hope you can all stay safe.
